- We purchase from local suppliers to the site to reduce the carbon footprint of deliveries, wherever possible and practical, encouraging use of sustainable transport and will work with organisations to achieve reductions in CO2 emissions.
- Where possible and practicable we purchase items that can be reused or recycled at the end
  of life to avoid the need to dispose of items to landfill. We always consider the end-of-life
  use or disposal when purchasing subject to approval by the client. Where non-sustainable
  materials are specified, we will offer a suitable sustainable alternative, if applicable and
  financially viable.
- We will continue to actively seek to recruit personnel from the local area to reduce the need for travel to the workplace.
- All staff travelling to Harniss projects where public transport is not practical are expected to car share and information is available on the Company intranet to support this.
- Telephone and video conferencing facilities are available and are used where possible to avoid the need for travel.
- Continual improvement and increasing of benefits to society, the environment, and the economy through its activities.
- Encouraging the cooperation and involvement of its employees, at all levels, for the effective implementation of this policy.

- Specify and procure materials and products that strike a responsible balance between social, economic, and environmental factors and generate benefits to society and the economy.
- Use resource-efficient products and give due consideration to end-of-life uses.
- Promote, specify, and source materials which can be reused and consider future deconstruction and recovery of resources to embrace the circular economy.
- Where reasonably practicable, procure locally, providing opportunities for small and medium sized enterprises (SMEs), collaborate with the voluntary sector and increase the use of social enterprises.
- Ensure that fair contract prices and terms are applied and respected and that ethical, human rights and labour standards are met, in line with our Modern Slavery Policy.
- Promote materials and products that improve indoor environmental quality.
- Maintain membership of the Sustainability Supply Chain School.
